## ASSIGNMENT OF PATENTS

NOW THEREFORE, be it known that, for good and valuable consideration, receipt of which is hereby acknowledged, including but not limited to a Purchase and Sale Agreement dated July 31, 2002, Beck hereby sells, assigns, transfers, and sets over to Becwill, its lawful successors and assigns, Beck's entire right, title, and interest in and to U.S. Patent Numbers 5467977 and D338248, and the inventions claimed therein, any other patent application directed to the inventions, and all Letters Patent of the United States that may be granted thereon, and all reissues, reexaminations, and extensions thereof; and all rights to claim priority on the basis of such application, and all applications for Letters Patent that may be filed for the inventions in any foreign country and all Letters Patent that may be granted on the inventions in any foreign country, and all extensions, renewals, and reissues thereof; and Beck hereby authorizes and requests the Commissioner of Patents and Trademarks of the United States and any official of any foreign country whose duty it is to issue patents on applications as described above, to issue all Letters Patent for these inventions to Becwill, its successors and assigns, in accordance with the terms of this Assignment;

AND, BECK HEREBY further sells, assigns, transfers, and sets over to Becwill, its lawful successors and assigns, Beck's entire right, title, and interest to prosecute and sue fully for any past or present patent infringements related to U.S. Patent Numbers 5467977 and D338248, and the inventions claimed therein;



rightful oaths, and generally do everything possible to aid Becwill, its successors and assigns, to obtain and enforce proper patent protection for the inventions in the United States and any foreign country, it being understood that any expense incident to the execution of such papers shall be borne by Becwill, its successors and assigns.


