PATENT ASSIGNMENT

WHEREAS, Oven Ready Foods, LLC, a Minnesota limited liability company, having a principal place of business at 22000 Industrial Boulevard, Suite 600, Rogers, MN 55374 (the Assignor), is the owner of certain new and useful invention as disclosed in Letters Patent No. US 6,450,341 B1 entitled "Shipping and Baking Package for Food Items," filed February 9, 2001 with the United States Patent and Trademark Office (Patent Office) and issued on September 17, 2002; and

WHEREAS, Blue Sky Foods, LLC, a Minnesota limited liability company, having a principal place of business at 750 Navajo Road West, Medina, MN 55340 (the Assignee), is desirous of acquiring the entire right, title and interest in and to said invention, any and all United States and foreign Letters Patent that may be issued thereon, and any improvements thereto;

NOW, THEREFORE, for good and other valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor hereby sells, assigns and transfers to the Assignee, and its legal representatives, successors and assigns, the entire right, title and interest in and to said invention and in and to all United States and foreign Letters Patents that may be issued for said invention, and in and to all patent applications, continuations, continuations-in-part, divisionals, reexaminations and reissues of said invention in the United States and in any and all foreign countries, as fully and completely as the same would have been held by Assignor had this Assignment and sale not been made, together with all claims for damages by reason of past, present or future infringement with the right to sue for and collect the same and obtain all other possible remedies for Assignee's own use and enjoyment and for the use and enjoyment of Assignee's successors, assigns or other legal representatives. The said entire right, title and interest shall vest irrevocably in Assignee. Assignor further agrees upon request, without additional compensation but at no expense to Assignor, to execute or assent to foreign applications, and to execute all other legal documents as may be necessary or desirable to vest the enjoyment of the said entire right, title and interest hereby transferred to Assignee, its legal representatives, successors and assigns, or as the Assignee may direct.

Assignor covenants that it has not executed any instrument or taken any action contrary to this Assignment, nor will Assignor do so in the future. Assignor further covenants that Assignor, or its executors, administrators, representatives or assigns will execute all papers, assignments or other documents as requested by Assignee, will provide testimony by affidavit or otherwise on behalf of Assignee, in any proceeding before the United States Patent and Trademark Office, foreign patent office, state or federal court, or other decision-making body, and in general will cooperate fully with Assignee, or its successors and assigns in the endeavor to secure, perfect, maintain or enforce any rights under said inventions, applications, or patents of the United States or any foreign countries which may be issued for said inventions.

The Commissioner of Patents, and the officials with comparable authority over patents in foreign countries, are hereby authorized and directed to issue, in accordance with this Assignment, any and all patents which may be granted as a result of said applications or any such continuations or counterparts thereof, or otherwise granted on said inventions.
