WHEREAS, Triple Keen Industrial Ltd. ("TKI") is a corporation organized and existing under the laws of Hong Kong, and is located at Suite 1501-04, 15/F, Two Chinachen Exchange Square, No. 338 King's Road, North Point, Hong Kong, China;

WHEREAS, Kam Sau Tang ("the Inventor") invented new and useful improvements in:

("the Invention"), for which the Inventor filed an application for U.S. Letters Patent with the United States Patent and Trademark Office on November 13, 2000, United States Patent Application No. 09/711,617 ("the Application");

WHEREAS, TKI is the record owner of United States Patent Application No. 09/711,617;

WHEREAS, Triple Keen Industrial (Holdings) Limited, "TKI Holdings" is a corporation organized and existing under the laws of Hong Kong, and is located at Flat/Room 1008, Dannies House, 20 Luard Road, Wanchai, Hong Kong, China;

WHEREAS, TKI Holdings desires to acquire all right, title and interest in and to the Application, the Invention and all other rights related thereto;

WHEREAS, TKI desires to assign and transfer TKI Holdings all rights, title and interest in and to the Application, the Invention and all other rights related thereto;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, TKI sells, assigns and transfers to TKI Holdings, its successors and assigns, the entire right, title and interest in and to said improvements and in and to any Letters Patent which may be obtained thereon in the United States, together with the Application and all divisional, continuing, substitute, renewal, reissue, and other applications for Letters Patent which have been or may be filed on said improvements in the United States, and all rights of priority resulting from any application for Letters Patent filed on said improvements; the same to be held and enjoyed by TKI Holdings for its and their sole use and behoof.

TKI hereby authorizes and requests the Commissioner for Patents and Trademarks to issue all Letters Patent of the United States on said improvements to TKI Holdings.

TKI further covenants and agrees that when requested by TKI Holdings, and without further consideration, but at the cost and expense of TKI Holdings, TKI will execute and deliver all applications for Letters Patent of the United States on said

improvements, execute all lawful oaths and other papers, supply to TKI Holdings all facts and evidence known to TKI relating to said improvements and the history and development thereof, testify in all interferences, suits, and other legal proceedings, and generally do everything rightful which TKI Holdings shall consider desirable for aiding in securing, maintaining, and enforcing proper patent protection for said improvements and for vesting title in and to said improvements in TKI Holdings.

TKI further covenants that it has the lawful right to assign the interest in said improvements in the manner and form as herein expressed, that it has not executed, and will not execute, any agreements in conflict therewith, and that the interests herein conveyed are free prior assignment, grant, mortgage, license, or other encumbrance whatsoever.
