

PATENT ASSIGNMENT

Notwithstanding the foregoing, the above assignment specifically excludes any rights to foreign counterparts of the Patents.

Assignor agrees to execute, at Assignee's expense, any further papers and to do such other acts as may be reasonably necessary and proper, or otherwise required by the Asset Purchase and Contribution Agreement, to vest full title in and to the Patents in Assignee.
