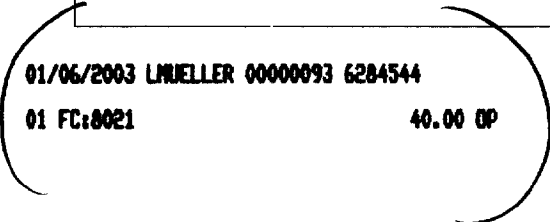

been held and enjoyed by Daniel Elbaum and David Christianson if this assignment and sale had not been made.


