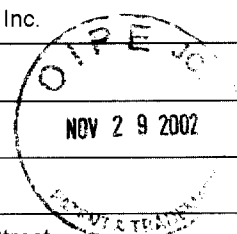


**Kiln Cleaning Apparatus**


