ASSIGNMENT OF UNITED STATES PATENT APPLICATION

WHEREAS, we, **Fredrik L.N. Kallin** and **Owen H. Wilson**, of Waterloo, Ontario, Canada and Kitchener, Ontario, Canada, respectively, have invented certain new and useful improvements in **VARIABLE PRESSURE DOCUMENT INFEED TRANSPORT APPARATUS FOR USE IN A SELF-SERVICE TERMINAL**, Docket No. **11070.00**, for which we have executed an application for Letters Patent of the United States on same date herewith, respectively; and


