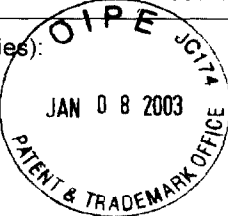

ASSIGNMENT

THIS ASSIGNMENT DEED made this 14th day of AUGUST, 2002
BETWEEN FIREBELT PTY LTD, (A.C.N. 054 417 739), 10-12 Pacific Highway, Chinderah
New South Wales, 2487, Australia, (hereinafter referred to as the ASSIGNOR which
expression shall include all successors and assigns) of the one part.

AND ^SPATENT4US ^{1/8/03}PTY LTD, (A.C.N. 101 505 953), of 10-12 Chinderah Bay Drive,
Chinderah, New South Wales, 2487, Australia, (hereinafter referred to as the ASSIGNEE
which expression shall include all successors and assigns) of the other part.

WHEREAS:-

1. The ASSIGNOR is the owner of certain patents and patent applications (hereinafter referred to as the patents) as listed in the schedule hereto;
2. The ASSIGNOR now desires to assign to the ASSIGNEE and the ASSIGNEE desires to take title of the patents and all right of action, powers and benefits thereto belonging or accrued and in particular the right to commence proceedings and obtain relief for any infringement of any one or more of the patents including any infringement which has occurred prior to the date hereof.

NOW THIS DEED WITNESSETH:-

Pursuant to the foregoing and in consideration of the sum of two dollars (\$2.00) and for other valuable consideration in hand well and truly paid to the ASSIGNOR by or on behalf of the ASSIGNEE the receipt and sufficiency of which are hereby acknowledged, it is hereby agreed between the parties as follows:-

1. The ASSIGNOR hereby assigns to the ASSIGNEE its whole right, title and interest in and to the patents and the right to file in ASSIGNEE'S name any further applications claiming priority from any one of the patents;
2. The ASSIGNOR assigns the patents to the ASSIGNEE as the beneficial owner subject to the condition that the ASSIGNOR does not and shall not be required to warrant or guarantee the validity of any of the patents and designs;
3. The ASSIGNOR hereby authorises the relevant government authority to transfer the patents and record this assignment in favour of the ASSIGNEE as assignee of the whole right, title and interest in and to the patents or otherwise as the ASSIGNEE may direct;

4. The ASSIGNOR hereby undertakes at the expense of the ASSIGNEE to do all acts and execute all documents necessary or desirable for further assuring the title of the ASSIGNEE to the patents;

5. Should the ASSIGNOR fail to comply with the undertaking in Clause 4, it hereby irrevocably appoints the ASSIGNEE and each of its directors, managers and secretary to be its several attorneys to, in its name and as its act and deed from time to time, if and when such attorney shall think fit for giving effect to the undertaking given by the ASSIGNOR in Clause 4, execute all such documents referred to in Clause 4 and if necessary, procure the registration of this attorney;

6. A Statutory Declaration by an officer of the ASSIGNEE shall be sufficient proof that the ASSIGNOR has failed to comply with its undertaking given in Clause 4.
