ASSIGNMENT

WHEREAS, we, Lawrence R. Porter, a citizen of United States of America and resident of Dallas County, and the State of Texas, and John Paul King, a citizen of United States of America and resident of Tarrant County, and the State of Texas, and Doug Justice, a citizen of United States of America and resident of Clackamas County, and the State of Oregon, have invented certain new and useful improvements in a "Wireless Communication Device for Electric Meter and Method of Manufacture Thereof" disclosed in an application for United States Letters Patent (Application No. 10/265,899, filed 10/07/2002), said application having been previously executed.

We hereby further agree that we will communicate to said ASSIGNEE, or to its successors, assigns and legal representatives, any facts known to us respecting any improvements; and, at the expense of said ASSIGNEE, to testify in any legal proceedings, sign all lawful papers, execute all divisional, continuation, continuation-in-part, reissue and substitute applications, and make all lawful oaths, and generally do everything possible to vest title in said ASSIGNEE and to aid said ASSIGNEE, its successors, assigns and legal representatives to obtain and enforce proper protection for said invention in all countries.

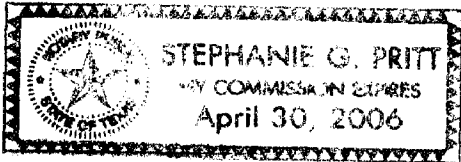

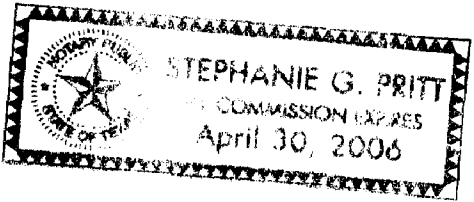
