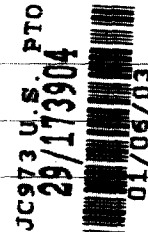

WHEREAS, I, Gregg A. 

I also agree to provide any reasonable information or assistance to Assignee in any infringement actions Assignee shall decide to initiate in order to

enforce the patent rights being transferred herein provided, however, all expenses incurred in such infringement actions shall be paid entirely by Assignee.
