ASSIGNMENT AND AGREEMENT

WHEREAS, **William R. Campbell** of P.O. Box 1016, Jamestown, NC 27282; **Kathleen G. Palma** of 815 Cliff Drive, McLeansville, NC 27301 and **Neil E. Paulsen** of 864 Southwest Drive, Davidson, NC 28036; (hereinafter referred to singly and collectively as "ASSIGNOR") have invented a certain invention entitled **METHODS AND COMPOSITIONS FOR TREATING ECTOPARASITE INFESTATION** (Atty. Dkt. No. 042644-0301) for which an application for United States Letters Patent was filed on April 29, 2002 as Application No. 10/136,075; and

ASSIGNOR HEREBY AGREES (a) to communicate to ASSIGNEE, its successors and assigns, or their representatives or agents, all facts and information known or available to ASSIGNOR respecting said invention or inventions, improvements, and modifications including evidence for interference, reexamination, reissue, opposition, revocation, extension, or infringement purposes or other legal, judicial, or administrative proceedings, whenever requested by ASSIGNEE; (b) to testify in person or by affidavit as required by ASSIGNEE, its successors and assigns, in any such proceeding in the United States or a country foreign thereto; (c) to execute and deliver, upon request by ASSIGNEE, all lawful papers including, but not limited to, original, divisional, continuation, and reissue applications, renewals, assignments, powers of attorney, oaths, affidavits, declarations, depositions; and (d) to provide all reasonable assistance to ASSIGNEE, its successors and assigns, in obtaining and

enforcing proper title in and protection for said invention or inventions, improvements, and modifications under the intellectual property laws of the United States and countries foreign thereto.

ASSIGNOR HEREBY REPRESENTS AND WARRANTS that ASSIGNOR has the full and unencumbered right to sell, assign, and transfer the interests sold, assigned, and transferred herein, and that ASSIGNOR has not executed and will not execute any document or instrument in conflict herewith.

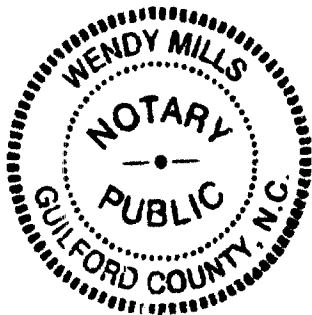

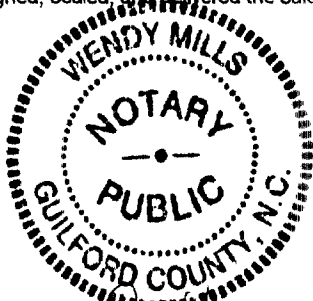

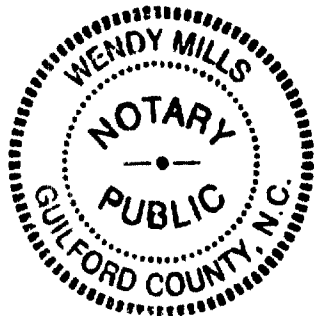
