## ASSIGNMENT

WHEREAS, I, Jean-Laurent PRADEL, residing at Rue Guillaume de la Tremblaye, 27300 Bernay, France, have invented certain new and useful improvements in and to the subject matter of:

### **COMPOSITION BASED ON ISOTACTIC POLYPROPYLENE OBTAINED BY METALLOCENE CATALYSIS AND ON GRAFTED ISOTACTIC POLYPROPYLENE OBTAINED BY ZIEGLER-NATTA CATALYSIS**

described in an application for United States Letters Patent filed on October 11, 2002, and accorded Application No. 10/268,916,;

AND, WHEREAS, ATOFINA S.A., a corporation organized under the laws of France, having a place of business located at 4-8 Cours Michelet, La Defense 10, F-92091 Paris La Defense Cedex, France (hereinafter "ASSIGNEE"), is desirous of acquiring certain rights to the improvements and under the application;

AND I hereby authorize and request our agents, Hunton & Williams, 1900 K Street, N.W., Suite 1200, Washington, DC 20006-1109, to insert hereon any identification necessary or desirable for recordation of this document, including the filing date and application number of said application when known.

AND I hereby agree for myself and my heirs, executors and administrators to execute without further consideration any further documents and instruments which may be necessary, lawful and proper in the prosecution of said above-referenced application or in the preparation or prosecution of any continuing, substitute, divisional, renewal, reexamination or reissue application or in any amendments, extensions or interference proceedings, or other applications for patents of any region or country, that may be necessary to secure to ASSIGNEE its interest and title in and to said improvements or any parts thereof, and in and to said several patents or any of them;

AND I hereby covenant for myself and my legal representatives, and agree with said ASSIGNEE, its successors and assigns, that I have granted no right or license to make, use, sell or offer to sell said improvements, to anyone except said ASSIGNEE, that prior to the

execution of this deed, my right, title and interest in said improvements had not been otherwise encumbered, and that I have not and will not execute any instrument in conflict therewith;

AND I do hereby authorize and request the Director of the United States Patent and Trademark Office to issue any and all letters patent which may be granted upon said United States applications, or upon said improvements or any parts thereof when granted, to said ASSIGNEE.
