1. He is the President and Secretary of Transilica Inc., a California corporation.
2. Article 1 of the Articles of Incorporation of this corporation, as amended to date, is amended to read as follows:


“ARTICLE 1

The name of this Corporation is Microtune (San Diego), Inc.”

3. The foregoing amendment of Articles of Incorporation has been duly approved by the board of directors.
4. The foregoing amendment of Articles of Incorporation has been duly approved by the required vote of shareholders in accordance with Section 902, California Corporations Code. The total number of outstanding shares of the corporation is 19,926,500 shares of Common Stock, 11,250,000 shares of Series A Preferred Stock and 17,052,314 shares of Series B Preferred Stock. The number of shares voting in favor of the amendment equaled or exceeded the vote required. The percentage vote required was more than 50%.
