WHEREAS, Diversified Acquisition Company United States, LLC ("DACUS"), a New Jersey Limited Liability Company with an address of 226 Prospect Street, Ridgewood, New Jersey 07450, (hereinafter collectively referred to as "Assignee") is desirous of acquiring M2's entire fifty (50%) percent of the right, title and interest in and to the Letters Patent(s);

NOW THEREFORE, for good and valuable consideration, the receipt and adequacy of which is hereby acknowledged, M2 hereby sells, assigns, conveys and transfers to DACUS, and its successors and assigns, its entire fifty (50%) percent of the right, title and interest in and to said Letters Patent(s), including all pending and future rights thereto including, but not limited to, any and all continuation applications, reissues, or re-examinations of any patents issuing on the indicated applications, as well as all applications directed to improvements thereof, and including any foreign rights therein, to be held by Assignee, subject to a certain ownership agreement of even or nearly even date herewith, between MPDI and DACUS, for its own use and benefit and for those of its assigns to the full end of the term for which such Letters Patent are granted as fully as it would have been held by M2 had this Assignment and sale not been made.


