PATENT ASSIGNMENT

WHEREAS, KERRY J. CORNELIUS, of Ontario, Canada ("Assignor"), has invented a new and useful "POOL WALL CONSTRUCTION," new and useful "ABOVE GROUND POOL COMPONENTS," and a new and useful "EARTH BRACE SYSTEM FOR SWIMMING POOLS -- IN THE GROUND" (collectively, the "Inventions") for which United States Letters Patents issued as U.S. Patent Nos. 5,325,644, 5,425,144, and 5,522,188, respectively (collectively, the "Patents"); and

Assignor represents and warrants that he has not granted and will not grant to others any rights inconsistent with the rights granted by this Assignment.

Assignor authorizes and requests the Commissioner of Patents and Trademarks of the United States and of all foreign countries to issue any Letters Patent granted for the Inventions, or on any subsequently filed division, continuation, continuation-in-part or reissue application, to Assignee, its successors and assigns, as the assignee of the entire interest in the Inventions.
