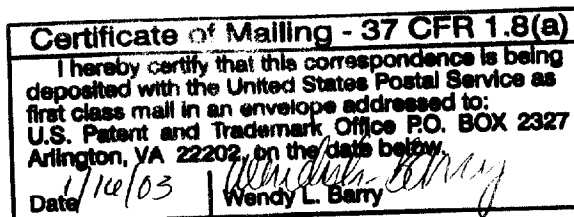

ASSIGNMENT



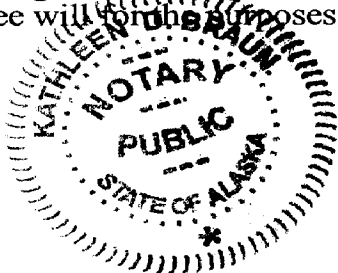



