WHEREAS, We, Gabor Kalman, Citizen of the United States of America, and Colin E. Huggett, citizen of the United States of America, residing respectively at 29422 Whitley Collins Dr, Palos Verdes, CA 90275 and 5202 Paseo Del Pavon, Torrance, Ca. 90505 (hereinafter ASSIGNORS), have made a certain invention entitled,

“Method And System For Providing Current Limiting Controllers For High Reactance Permanent Magnet Generators”

AND WE HEREBY covenant that we have the full right to convey the entire right, title and interest herein assigned and that we have not executed and will not execute any assignment or other instrument in conflict herewith;


