PATENT ASSIGNMENT
FROM GEORGE A. JEFFREYS & CO., INC. TO
NOVOZYMES A/S

A. George A. Jeffreys & Co., Inc. ("Seller") and Novozymes A/S ("Buyer") have entered into an Asset Purchase Agreement, dated as of May 10, 2002 (the "Asset Purchase Agreement") (capitalized terms not otherwise defined herein shall have the meanings assigned to such terms in the Asset Purchase Agreement), whereby Seller has agreed to sell all of Seller's right, title and interest in and to certain assets of Seller described in Section 1.1 and the Exhibits thereto to the Asset Purchase Agreement to Buyer at the Closing in consideration for the payment by Buyer to Seller of the Purchase Price as set forth in Article III of the Asset Purchase Agreement; and

B. Buyer wishes to acquire all of Seller's rights, title and interests in the United States Patent set forth in Schedule 1 hereto which is incorporated herein by reference ("Patent"); and


C. The parties desire that this Assignment shall and does formalize certain of the conveyances and transactions contemplated by the Asset Purchase Agreement.

NOW, THEREFORE: that for good and valuable consideration, the receipt and legal sufficiency of which is hereby acknowledged, and the performance by Buyer of its obligations set forth in the Asset Purchase Agreement, including payment of the Purchase Price, receipt of which is hereby acknowledged by Seller, Seller does sell, assign and transfer unto Buyer its entire right, title and interest in and to the Patents, to the extent they are subsisting; the same to be held and enjoyed by the Buyer for its own use, and for its successors, legal representatives and assigns, to the full end of the term for which said Patents are granted, as fully and entirely as the same would have been held by Seller had this assignment and sale had not been made.

The terms and conditions of this Agreement are subject in every respect to the terms and conditions of the Asset Purchase Agreement and, if in conflict, the terms and conditions of the Asset Purchase Agreement shall control.
