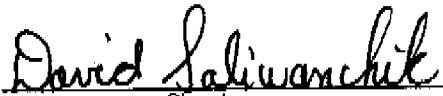

DEED OF ASSIGNMENT OF PATENTS AND PATENT APPLICATIONS

DEED OF ASSIGNMENT OF PATENTS AND PATENT APPLICATIONS

THIS DEED is made on 19 September 2002

BETWEEN

- (1) **QUADRANT HEALTHCARE (UK) LIMITED**, a company incorporated in England and Wales with registered number 02369749 whose registered office is at 1 Mere Way, Ruddington, Nottingham, NG11 6JS ("**QHL**"); and
- (2) **ELANDRUG DELIVERY LIMITED**, a company incorporated in England and Wales with registered number 02704727 whose registered office is at 1 Mere Way, Ruddington, Nottingham, NG11 6JS ("**EDD**").

INTRODUCTION

- (A) **QHL** is the proprietor of the Patents and the Patent Applications (as herein defined).
- (B) Pursuant to an agreement dated 24 December 2001, **QHL** agreed to sell and transfer to **EDD** the Patents and the Patent Applications (the "**Hive Up Agreement**").
- (C) **QHL** wishes to enter into this Deed in order to formally assign to **EDD** the Patents and the Patent Applications, in accordance with the terms of the **Hive Up Agreement**.
- (D) The parties wish to confirm their agreement as to the above on the terms and conditions set out below.

AGREED TERMS**1. Definitions**

- 1.1 In this agreement, unless the context requires otherwise, the following words and expressions shall have the following meanings:

"**Patents**" means the patents listed in Schedule A to this agreement.

"Patent Applications" means the patent applications and applications for rights of a similar nature listed in Schedule A to this agreement; all divisionals, continuations and continuations in part thereof; and all patent applications and applications for rights of similar nature made now or in the future anywhere in the world:

- (a) claiming priority from or common priority with the applications listed in Schedule A to this agreement; and
- (b) in respect of the same invention as that the subject of any of the patent applications listed in Schedule A to this agreement.

2. Assignment of Patents and Patent Applications

2.1 QHL hereby assigns to EDD absolutely all its property, right, title and interest in and to:

- (a) the Patents;
- (b) the Patent Applications;
- (c) the inventions the subject of such Patents and Patent Applications and in the right to apply for patents or other protection in respect of such inventions in any part of the world; and
- (d) any patents granted to QHL pursuant to the said Patent Applications;

TOGETHER WITH all rights of action, powers and benefits belonging or accrued to the same, including the right to take action and claim relief in respect of infringements occurring prior to the date hereof.

2.2 QHL will at EDD's cost take all reasonable steps requested by EDD in connection with obtaining the grant of valid patents pursuant to the said Patent Applications in any part of the world and, to the extent that the same are required to proceed in QHL's name prior to grant, will:

- (a) if required by EDD authorise and instruct patent agents of EDD for the purpose of obtaining such grants; and
- (b) in the event of the grant thereof assign to EDD absolutely any patent granted pursuant to the said Patent Applications in any part of the world.

3. Further Assurance

3.1 QHL will at EDD's request and expense promptly take all steps and do all acts and things and execute all documents and deeds as requested by EDD that EDD reasonably considers are necessary or desirable for giving full effect to the terms and provisions of this agreement and to vest all QHL's property, right, title and interest in EDD absolutely and for EDD to be recorded as proprietor of the Patents and applicant in respect of the Patent Applications at patent offices. EDD shall be responsible for and shall bear the registration or other official fees

relating to the assignment of the Patents and the Patent Applications and of preparing documents for execution.

4. Miscellaneous

4.1 This agreement shall be governed by and construed in accordance with the laws of England and Wales.

This agreement has been executed and delivered as a deed on the date first written above.

THIS DEED is made on 21 December 2001

BETWEEN:

- 1 **QUADRANT BIORESOURCES LIMITED** a company incorporated in England and Wales (registered number 1956520) whose registered office is at 1 Mere Way, Ruddington, Nottingham, Nottinghamshire, NG11 6JS (the "Assignor"); and
- 2 **QUADRANT HEALTHECARE (UK) LIMITED** a company incorporated in England and Wales (registered number 2369749) whose registered office is at 1 Mere Way, Ruddington, Nottingham, Nottinghamshire, NG11 6GS (the "Assignee");

RECITALS:

- (A) The Assignor is the proprietor of the Patents listed in the Schedule 1 to this Deed ("the Patents")
- (B) The Assignor granted to the Assignee on 7th December 1990 a licence of the Patents (the "Licence")
- (C) The Assignor has agreed to assign the Patents to the Assignee for the consideration hereinafter mentioned on the terms set out in this Deed and terminate the Licence.

1 ASSIGNMENT

- 1.1 In consideration of £50.00 (Fifty British Pounds Sterling) the Assignor assigns absolutely with full title guarantee to the Assignee free from all liens, charges, options, encumbrances and adverse interests of any kind:
 - 1.1.1 the Patents and the full and exclusive benefit of them; and
 - 1.2 the right to take all such proceedings as may be necessary for the recovery and retention by the Assignee of damages, costs and interest and/or the obtaining of other remedies in respect of all infringements of any of the Patents whether committed before or after the date of this Deed; and
 - 1.3 the right to apply for, prosecute and obtain patent or similar protection throughout the world in respect of the invention claimed in the Patents, including the right to claim priority therefrom so that the grant of any patent or similar protection shall be in the name of and vest in the Assignee.

2 TERMINATION OF LICENCE

The parties agree that the Licence shall terminate as at the date hereof.

3 FURTHER ASSURANCE

At all times after the date of this Deed the Assignor shall (at the request and cost of the Assignee) do or procure to be done all acts and things and/or execute or procure the execution of all documents required of it by the Assignee to vest in the Assignee (or as
