ASSIGNMENT

WHEREAS, I **Yousri M. Barri**, of 3560 Alma Road, Richardsun, TX 75080, (hereinafter collectively called "ASSIGNOR"), am inventor and owner of certain new and useful improvements in *Prevention and Treatment of Atherosclerosis by Reducing Carbamylation of LDL or the Effects of Carbamylated LDL*, an application for United States Letters Patent as filed August 27, 2002 as United States Serial No. 10/228,493.

And I do further covenant and agree that I will, at any time upon request, communicate to the Assignee, its successors, assigns or other legal representative, such facts relating to said invention and Letters Patent or the file history thereof as may be known to us, and testify as to the same in any interference or other litigation when requested, without further compensation but at the expense of said Assignee, its successors or other legal representatives.

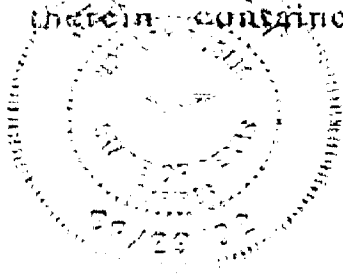
