## ***ASSIGNMENT***

WHEREAS, we, BRIAN MARKS, residing at 700 Fifth Avenue, Apartment 10, Pittsburgh, Pennsylvania 15139, ALAN S. ROSS, residing at 1168 Lakemont Drive, Pittsburgh, Pennsylvania 15243 and HANS A. This assignment shall be binding upon our heirs, executors, administrators, and/or assigns, and shall inure to the benefit of the heirs, executors, administrators, successors, and/or assigns, as the case may be, of said Assignee.

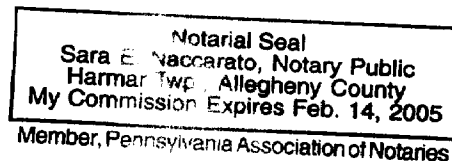

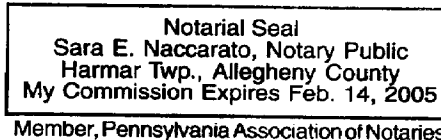


