A SIMPLIFIED MULTI-OUTPUT DIGITAL TO ANALOG CONVERTER (DAC) FOR A FLAT PANEL DISPLAY

priority contests, public use proceedings, reexamination proceedings, compulsory licensing proceedings, infringement actions and court actions; provided, however, that the expense incurred by said Inventor in providing such cooperation shall be paid for by said Assignee.
