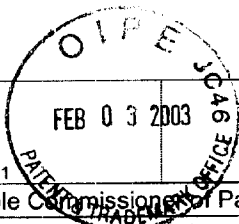




ASSIGNMENT
