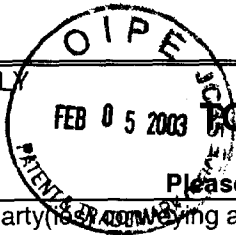

WHEREAS, Ian W. Cunningham and Kristofor M. Hallee, hereinafter called the "Assignors", have made the invention described in the United States patent application entitled DRILL BIT CASE, for a full description of which reference is here made to an application for Letters Patent of the United States filed on October 2, 2002, and assigned Application Serial No. 29/168,438;

The Commissioner of Patents and Trademarks is hereby authorized and requested to issue patents to the Assignee in accordance with the terms of this Assignment.


