## ASSIGNMENT

WHEREAS, I, June I. Medford (herein called "ASSIGNOR"), residing at 1331 Cape Cod Circle, Fort Collins, Colorado 80525 am a co-inventor of the invention "*Optical Coherence Microscope and Method of Use for Rapid In Vivo Three Dimensional Visualization of Biological Function*" for which an application for a Patent of the United States was filed January 28, 2000, Serial No. **09/493,896** and any foreign counterparts of the above applications that are pending or may have issued.

NOW, THEREFORE, in consideration for the sum of Ten Dollars (\$10.00) and other good and valuable consideration the receipt of which is hereby acknowledged, I the said ASSIGNOR, have sold, assigned, transferred and set over, and by these presents do hereby sell, assign, transfer and set over, unto the said ASSIGNEE, its successors, legal representatives and assigns, the entire right, title and interest in, to and under the said subject matter, and the said United States Patent Application and any right I may have in any United States patent applications taking priority from the said application, any renewals and continuations thereof, and all Patents of the United States which may be granted thereon and all reissues and extensions thereof; and all applications for industrial property protection, including, without limitation, all applications for patents, utility models, and designs which may hereafter be filed for said subject matter in any country or countries foreign to the United States, together with the right to file such applications and the right to claim for the same the priority of the said provisional application under The International Union for the Protection for Industrial Property, or any other international agreement or the domestic laws of the country in which any such application is filed, as may be applicable; and all forms of industrial property protection, including, without limitation, patents, utility models, inventors' certificates and designs which may be granted for said subject matter in any country or countries foreign to the United States and all extensions, renewals and reissues thereof;

AND I HEREBY authorize the above-mentioned assignee or its legal representative to insert in this instrument the filing date and serial number of our said application or any other information that may be necessary or desirable in order to comply with the rules of the United States Patent and Trademark Office for recordation of this document.

AND I HEREBY authorize and request the Commissioner of Patents and Trademarks of the United States, and any official of any country of countries foreign to the United States whose duty it is to issue patents or other forms of industrial property

protection on application as aforesaid, to issue the same to the said ASSIGNEE, its successors, legal representatives and assigns, in accordance with the terms of this instrument;

AND I HEREBY covenant and agree that I have the full right to convey my entire rights and interest herein assigned and that I have not executed and will not execute any agreement in conflict herewith;

AND I HEREBY further covenant and agree that I will communicate to the said ASSIGNEE, its successors, legal representatives and assigns, any facts known to us respecting said subject matter, and testify in any legal proceeding, sign all lawful papers, execute all regular United States patent applications and any divisional, continuing, reissue and foreign applications, make all rightful oaths, and generally do everything possible to aid said ASSIGNEE, its successors, legal representatives and assigns, to obtain and enforce proper protection for said subject matter in all countries.
