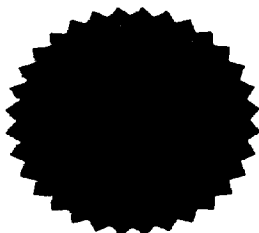

*(pursuant to the General Corporation Law of the State of Delaware)*

Procyon Pharmaceuticals, Inc., a corporation organized and existing under and by virtue of the General Corporation Law of the State of Delaware,

DOES HEREBY CERTIFY:

FIRST: That the Board of Directors of said corporation adopted by the unanimous written consent of its members, filed with the minutes of the Board, the following resolution proposing and declaring advisable an amendment to the Certificate of Incorporation of said corporation:

RESOLVED, that this Board of Directors recommend to the stockholders of the Corporation that the Corporation change its name to PKC Pharmaceuticals, Inc. and that the Certificate of Incorporation of Procyon Pharmaceuticals, Inc. be amended by changing the First Article thereof so that as amended, said Article shall be and read as follows:

FIRST: The name of the corporation is PKC Pharmaceuticals, Inc. (the "Corporation")."

SECOND: That in lieu of a meeting and vote of the stockholders, the stockholders have given written consent to said amendment in accordance with the provisions of Section 228 of the General Corporation Law of the State of Delaware and written notice of the adoption of the amendment has been given as provided in Section 228 of the General Corporation Law of the State of Delaware to every stockholder entitled to such notice.

THIRD: That the aforesaid amendment was duly adopted in accordance with the applicable provisions of Sections 242 and 228 of the General Corporation Law of the State of Delaware.
