And for the same consideration, the said Assignor hereby covenants and agrees to and with the said Assignee, his successors, legal representatives and assigns, that the said Assignor will, whenever counsel of the said Assignee, or the counsel of his successors, legal representatives and assigns, shall advise that any proceeding in connection with said inventions, or said application for Letters Patent or any proceeding in connection with Letters Patent for said inventions in any country, including interference proceedings, is lawful and desirable, or that any division, continuation or continuation-in-part of any application for Letters Patent, or any reissue or extension of any Letters Patent, to be obtained thereon, is lawful and desirable, sign all papers and documents, take all lawful oaths, and do all acts necessary or required to be done for the procurement, maintenance, enforcement and defense of Letters Patent for said inventions, without charge to the said Assignee, his successors, legal representatives and assigns, but at the cost and expense of the said Assignee, his successors, legal representatives and assigns.

And the said Assignor hereby requests the Commissioner of Patents and Trademarks to issue said Letters Patent of the United States to the said Assignee, as
