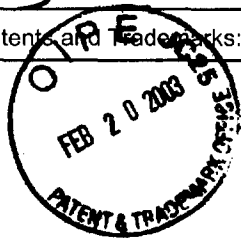



limited to, nullification, reissuing, extension, and infringement proceedings involving said invention.

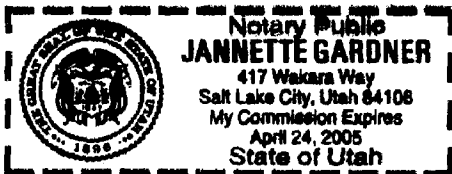
