WHEREAS, Hiroyuki YAMAMOTO, Kaoru NAKAJIMA, Kazunori KOSUGE, Katsutoshi MURATA, Hiroyuki MENJO, and Tsuyoshi IWAMOTO, hereinafter called the "Assignors", have made the invention described in the United States patent application entitled, POSITIONAL INFORMATION PROVIDING APPARATUS, COMMUNICATION TERMINAL, MOBILE COMMUNICATION TERMINAL, AND POSITIONAL INFORMATION PROVIDING METHOD, executed by Assignors on the same date as this Assignment;
