ASSIGNMENT

WHEREAS, Chin Yuan, a citizen of the United States of America, residing at 634 Lomond Circle, San Ramon, CA 94583; and Kuo-Hui Liu, a citizen of the United States of America, residing at 212 Alderwood Lane, San Ramon, CA 94583, hereinafter called the "Assignors", have made the invention described in the United States patent application entitled Virtual Interworking Trunk Interface and Method of Operating a Universal Virtual Private Network Device, Attorney Docket No. 1033-T00480, (SBC File No. T00480) for a full description of which reference is here made to an application for Letters Patent of the United States filed on November 15, 2002 and assigned Application Serial No. 10/298,266;

WHEREAS, SBC PROPERTIES, L.P., a partnership organized and existing under the laws of the State of Nevada, having a place of business at 645 E. AND said Assignors hereby covenant and agree, for both the Assignors and the Assignors' legal representatives, that the Assignors will assist the Assignee in the prosecution of the patent application identified above; in the making and prosecution of any other patent applications that the Assignee may elect to make covering the invention identified above; in vesting in the Assignee like exclusive title in and to all such other patent applications and patents; and in the prosecution of any interference which may arise involving said invention, or any such patent application or patent; and that the Assignors will execute and deliver to the Assignee to carry out the terms of this Assignment. Assignors authorize attorney or agent to fill in the U.S. Application Serial No. above, if required.

AND said Assignors authorize and request the Commissioner of Patents to issue Letters Patent on said application, and on any all divisions and continuations thereof, to said Assignee, its assigns and legal representatives, in accordance with the terms of this Assignment.
