


This Assignment and my promises herein also obligate my heirs, legal representative and assigns, and they are for the benefit of said Company and its successors and assigns.



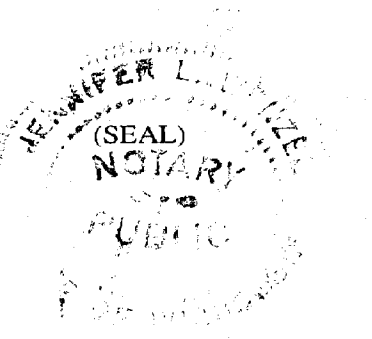
