



## ASSIGNMENT

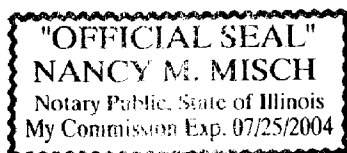
