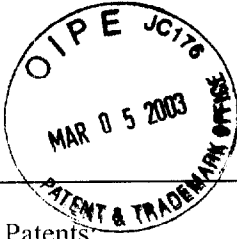

Now therefore, for and in consideration of the sum of One Dollar (\$ 1,00), and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties agree as follows :

GROSFILLEX SARL does hereby sell, assign, and transfer to GROSFILLEX USA, its lawful successors, assigns, and legal representatives, the entire right, title and interest in and to the Patents, together with the designs described in the Patents, and any extensions, reissues, substitutes, divisions, renewals, continuations, and continuations-in-part thereof, the same to be held and enjoyed by GROSFILLEX USA for its own use and enjoyment, and for the use enjoyment of its successors, assigns or other legal representatives, to the end of the term or terms for which the Patents are granted or reissued, as fully and entirely as the same would have been held and enjoyed by GROSFILLEX SARL, if this assignment had not been made, together with the right to apply for other forms of protection in the United States, and all claims for relief (including damages and injunctions) by reason of infringement or past infringement of any of the Patents, with the right to sue for, and collect the same for, its own use and benefit and for the use and benefit of its successors, assigns, and legal representatives.

GROSFILLEX SARL does hereby further assign, transfer and convey to GROSFILLEX USA, its lawful successors, assigns, and legal representatives, any rights GROSFILLEX SARL may have in and to any other intellectual property rights in the United States, including, any trade dress (and the goodwill of the business associated therewith), copyrights, or related federal or state rights (other than the trademark GROSFILLEX), directly related to the Patents or designs embodied in the Patents, and all claims for relief (including damages and injunctions) by reason of infringement or past infringement or violation of any such intellectual property rights, with the right to sue for, and collect the same for, its own use and benefit and for the use and benefit of its successors, assigns, and legal representatives.

GROSFILLEX SARL, hereby authorizes the Commissioner of Patents and Trademarks of the United States to issue any and all patents on the designs embodied in the Patents, or any extensions, reissues, substitutes, divisions, renewals, continuations, and continuations-in-part thereof, to GROSFILLEX USA as assignee thereof.
