ASSIGNMENT

WHEREAS, Akira KADONAGA, of c/o Sony Corporation, 7-35, Kitashinagawa 6-chome, Shinagawa-ku, Tokyo 141-0001 Japan, as assignor, has invented improvements in

IC CARD AND IC-CARD ADAPTER APPARATUS
