**WHEREAS**, I, the undersigned inventor (or one of the undersigned joint inventors), of residence as listed, having invented certain new and useful improvements as below entitled, for which application for United States Letters Patent is made, said application having been executed on the date set forth below; and

**WHEREAS**, Microtune (Texas), L.P. (hereinafter referred to as "Assignee"), a Texas Limited Partnership, with an address of 2201 Tenth Street, Plano, Texas 75074, desires to acquire my entire right, title and interest in and to the invention, and in and to the said application and any Letters Patent that may issue thereon;
