ASSIGNMENT

AND WE DO HEREBY authorize and request the Commissioner of Patents and Trademarks to issue that said Letters Patent, when granted, to the said Schwäbische Werkzeugmaschinen GmbH, a corporation, its successors and assigns, as assignees of the entire right, title and interest in and to said improvements, for the sole use and behoof of said Schwäbische Werkzeugmaschinen GmbH, a corporation, and for its successors and assigns, to the full ends of the terms for which Letters Patent may be granted.




