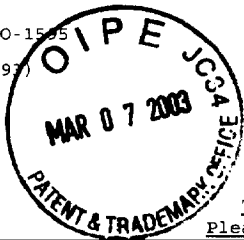



ASSIGNMENT

WHEREAS Tetrason Diversified Corp. (TDC) whose full post office address 75 Broadway Ave., Suite 414, Toronto Ontario, M4P-1V1 have all right title and interest in a certain new and useful improvement in an invention entitled TAPERED PLUG CUTTER for which an application for United States Letters Patent was made on August, 10, 2001 and accorded serial no. 09/925,725 under the above title,

TDC agrees that it will without further consideration do all such things and execute all such documents as may be necessary or desirable to obtain and maintain patents for said invention and for additions and modifications thereto in any and all countries, and to vest title hereto in said assignee, its successors, assigns and legal representatives or nominees, provided all such related costs are covered by MIBRO Partners.


