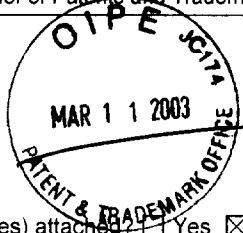

Further, the ASSIGNORS hereby covenant that they have the full right to convey the entire right, title and interest herein sold, assigned, transferred and set over;

Further, wherein, contrary to the recitation on the front page of the Letters Patent, stating that the Letters Patent is assigned to Atofina, the ASSIGNORS hereby affirm that they have not assigned the Letters Patent to Atofina or to any other party, said incorrect assignee information recited on the front page of the Letters Patent being due to an inadvertent error made during completion of the issue fee transmittal form for the Letters Patent and for which correction shall be sought.

And the ASSIGNORS hereby further covenant and agree that the ASSIGNEE, its successors, legal representatives, or assigns, may apply for foreign Letters Patent on said discovery or invention and claim the benefits of the International Convention, and that the ASSIGNORS will, at any time, when called upon to do so by the ASSIGNEE, its successors, legal representatives, or assigns, communicate to the ASSIGNEE, its successors, legal representatives, or assigns, as the case may be, any facts known by the ASSIGNORS respecting said discovery or invention, and execute and deliver any and all lawful papers that may be necessary or desirable to perfect the title to the said discovery or invention, the said applications and the said Letters Patent in the ASSIGNEE, its successors, legal representatives and assigns, and that if reissues of the Letters Patent or disclaimers relating thereto, or divisions, continuations, or refilings of the said applications, or any thereof, shall hereafter be desired by the ASSIGNEE, its successors, legal representatives, or assigns, the ASSIGNORS will, at any time, when called upon to do so by the ASSIGNEE, its successors, legal representatives or assigns, sign all lawful papers, make all rightful oaths, execute and deliver all such disclaimers and all divisional, continuation and reissue applications so desired, and do all lawful acts requisite for the application for such reissues and the procuring thereof and for the filing of such disclaimers and such applications, and generally do everything possible to aid the ASSIGNEE, its successors, legal representatives and assigns, to obtain and enforce proper patent protection for said invention or discovery in all countries, all without further compensation but at the expense of the ASSIGNEE, its successors, legal representatives and assigns.
