

ASSIGNMENT

WHEREAS, I, Dean M. 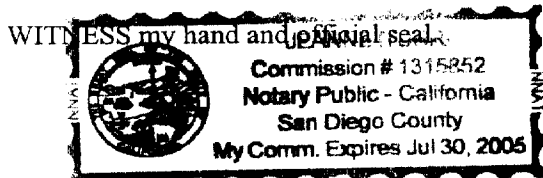
