FOR GOOD AND VALUABLE CONSIDERATION, the receipt, sufficiency and adequacy of which are hereby acknowledged, the undersigned ASSIGNOR does hereby:

SELL, ASSIGN AND TRANSFER to **Albin J. Tiley**, an individual residing at 2753 East Canyon View Drive, Salt Lake City, Utah 84109; **Diane L.
