**ASSIGNMENT AND AGREEMENT**  
**Joint Inventors**

WHEREAS, Anthony J. Bauer, County of Madison, State of Illinois; Thomas R. Callahan, County of Madison, State of Illinois; Edward R. Hanson, County of Madison, State of Illinois; Charles Moehling, County of Cook, State of Illinois; Ronald R. Evers, County of Stark, State of Ohio; Brian A. Parrish, County of Saint Louis, State of Missouri; hereinafter called the "Assignors", have invented certain new and useful improvements in a **METHOD OF MAKING SIDEFAMES FOR RAILWAY CAR TRUCKS** for a full description of which reference is here made to an application for Letters Patent of the United States and identified as their attorney's Case No. 6154-DIV E, executed on even dates herewith; and
