

Upon receipt of said consideration, ASSIGNOR does hereby covenant and agree with ASSIGNEE, its successors and assigns, that ASSIGNOR has not and will not execute any writing or do any act whatsoever conflicting with this assignment.

I declare under penalty of perjury under the laws of the United States of America that I am Chairman and Chief Executive Officer of the above-identified ASSIGNOR, that I have signed this document on behalf of ASSIGNOR with the full authority of its board of directors, and that all of the foregoing is true and correct.
