

Exhibit D**ASSIGNMENT OF PATENTS**

WHEREAS, Into Networks, Inc., a corporation organized and existing under the laws of the State of Delaware (the "Seller"), is the owner of the entire right, title and interest in and to certain inventions or discoveries (or both) set forth in certain United States and foreign patents and applications as specified in Schedule A attached hereto and made a part hereof (collectively, the "Patent Rights"); and

WHEREAS, Seaport Software Solutions, LLC, a limited liability company organized and existing under the laws of the State of Delaware (the "Purchaser"), has acquired the entire right, title and interest in and to certain assets and properties of the Seller, including the Patent Rights (collectively, the "Assets"), pursuant to that certain Asset Purchase Agreement by and between the Seller and the Purchaser dated as of July 8, 2002 (the "Agreement"); and

WHEREAS, pursuant to the Agreement the Seller has agreed to execute such additional instruments as may be necessary or desirable to confirm said acquisition of the Assets by the Purchaser.

NOW, THEREFORE, in consideration of the foregoing, as well as for other good and valuable consideration the receipt of which is hereby acknowledged, the Seller hereby, without reservation:

1. Assigns, transfers and conveys to the Purchaser the entire right, title and interest in and to the Patent Rights, including, without limitation, said inventions, discoveries, patents and applications therefor in whatsoever countries, including all divisional, renewal, substitute, nonprovisional, continuation and Convention applications based in whole or in part upon said inventions or discoveries, or upon said applications, and any and all Letters Patent, reissues, reexaminations, and extensions of Letters Patent granted for said inventions and discoveries or based upon said applications, and every priority right that is or may be predicated upon or arise from said inventions, said discoveries, said applications and said Letters Patent;
2. Authorizes the Purchaser to file patent applications in any or all countries on any or all of said inventions and discoveries in the Seller's name or in the name of the Purchaser or otherwise as the Purchaser may deem advisable, under the International Convention or otherwise;
3. Authorizes and requests the Commissioner of Patents and Trademarks of the United States of America and the empowered officials of all other governments to issue or transfer all said Letters Patent and applications therefor to the Purchaser, as assignee of the entire right, title and interest therein or otherwise as the Purchaser may direct;
4. Warrants that it has not knowingly conveyed to others any right in said inventions, discoveries, applications or patents or any license to use the same or to make, use or sell anything

embodying or utilizing any of said inventions or discoveries; and that it has good right to assign the same to the Purchaser without encumbrance;

5. Binds its successors and assigns, as well as itself, to do, upon the Purchaser's request and at the Purchaser's expense, but without additional consideration to the Seller, all acts reasonably serving to assure that the said inventions and discoveries, the said patent application and the said Letters Patent shall be held and enjoyed by the Purchaser as fully and entirely as the same could have been held and enjoyed by the Seller, its successors and assigns if this assignment had not been made; and particularly to execute and deliver to the Purchaser all lawful application documents including petitions, specifications, and oaths, and all assignments, disclaimers, and lawful affidavits in form and substance as may be requested by the Purchaser; to communicate to the Purchaser all facts known to the Seller relating to said inventions and discoveries or the history thereof; and to furnish the Purchaser with any and all documents, photographs, models, samples and other physical exhibits in the Seller's control or in the control of its successors or assigns which may be useful for establishing the facts of all conceptions, disclosures, and reduction to practice of said inventions and discoveries.
