The undersigned, in order to form a corporation pursuant to Section 102 of the General Corporation Law of the State of Delaware, does hereby certify:

I. The name of the corporation:

LASKO HOLDINGS, INC.

- II. The location of the corporation's registered office in Delaware is at 1209 Orange Street, City of Wilmington, County of New Castle, Delaware 19801. The name of the registered agent at such address is The Corporation Trust Company.
- lawful act or activity for which corporations may be organized under the General Corporation Law of the State of Delaware, except that within the State of Delaware, its activities shall be confined to the maintenance and management of its intangible investments (as that term is defined in Section 1902(b)(8) of Title 30 of the Delaware Code, or successor provisions of similar import), and the collection and distribution of the income from such investments or from tangible property physically located outside this State of Delaware.
- IV. The Corporation shall have authority to issue 1,000 shares of common stock with no stated par value per share.

afforded to such director by this Article with respect to any act or omission of such director occurring prior to such amendment, repeal, or adoption of such provision.

Whenever a compromise or arrangement is proposed TX. between this Corporation and its creditors or any class of them and/or between this Corporation and its stockholders or any class of them, any court of equitable jurisdiction within the State of Delaware may, on the application in a summary way of this Corporation or of any creditor or stockholder thereof or on the application of any receiver or receivers appointed for this Corporation under the provisions of §291 of Title 8 of the Delaware Code or on the application of trustees in dissolution or of any receiver or receivers appointed for this Corporation under the provisions of §279 of Title 8 of the Delaware Code, order a meeting of the creditors or class of creditors, and/or of the stockholders or class of stockholders of this Corporation, as the case may be, to be summoned in such manner as the said court directs. If a majority in number representing three-fourths in value of the creditors or class of creditors, and/or of the stockholders or class of stockholders of this Corporation, as the case may be, agree to any compromise or arrangement and to any reorganization of this Corporation as consequence of such compromise or arrangement, the said compromise or arrangement and the said reorganization shall, if sanctioned by the court to which the said application has been made, be binding on all the creditors or class of creditors, and/or on all the stockholders or




