3. The date of adoption of the aforesaid amendment was May 6, 1998.


4. Only one voting group was entitled to vote on the said amendment to the Articles of Incorporation.

5. The number of votes cast for the amendment to the Articles of Incorporation by the said voting group was sufficient for the approval thereof.


