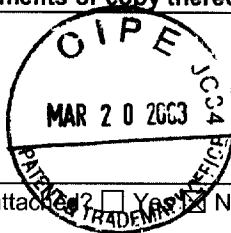

for which We filed an application for United States Letters Patent on December 4, 2002 (Application No. 10/309,317); and


