Assignor agrees to execute and provide promptly after the execution hereof, such further instruments, documents or assignments as may reasonably be necessary to effectuate the purposes of this Assignment and to consolidate, vest and record in Assignee the full ownership of the Patent Rights and the right to recover for past infringements, and any licenses or authorizations to use the Patent Rights granted by Assignor (or its predecessors) heretofore.



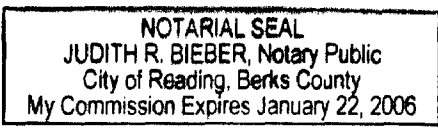
