WHEREAS, I, Charles E. Covatch, a citizen of United States, reside at 150 Ridgeview Lane; Martinsburg; PA 16662, and have made certain inventions or discoveries (or both) as set forth in an application for Letters Patent of the United States of America, entitled **Shoe Having A Multilayered Insole**; application of which is attached hereto;
