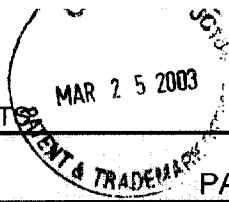

## ASSIGNMENT AND AGREEMENT



We hereby consent that a copy of this assignment shall be deemed a full legal and formal equivalent of any document which may be required in any country in proof of the right of **TeleCommunication Systems, Inc.** to apply for patent or other form of protection for said inventions and to claim the aforesaid benefit of the right of priority.



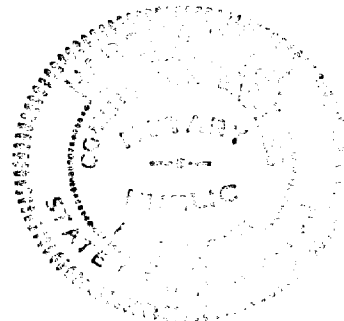


