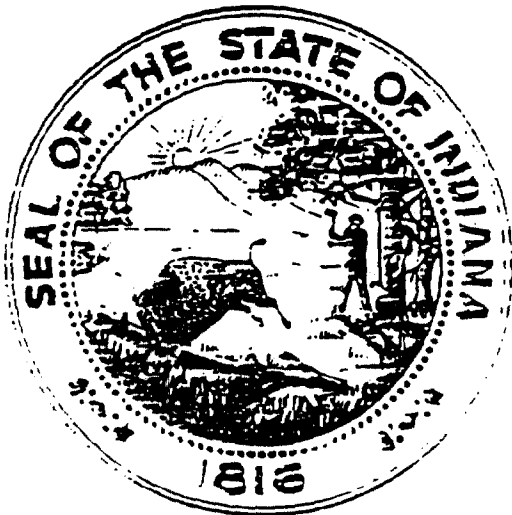

A decrease in the number of directors shall not shorten an incumbent director's term.
